- 4. Minutes from July 5, 2008- David Zeichick
  - a. Jim McDaniels moved to approve the minutes
  - b. Janice seconded the move
  - c. All approved
- 5. Summit Springs Introduction guest speaker: Judy Nunez
  - a. 4 years ago the Forest Service told the community that trailers must be removed. Cabin owners had three choices
    - i. Sell improved site
    - ii. Build a cabin by December 31<sup>st</sup>, 2010
      - 1. must be 1,400 square feet
    - iii. Turn land back over to the Forest Service
  - b. Majority of the community sold their lots
  - c. Five lots are currently for sale
    - i. 3 of these have plans for building
    - ii. 2 are hoping for an extension
  - d. At the end of this year permits to use the site will increase from \$375 per year to \$2,300 per year
- 6. Treasurer's Report Howard Wolff
  - a. \$13K in outstanding dues
  - b. \$128K reserves total (minus outstanding dues)
  - c. \$48K for roads
  - d. \$15k for land cleanup
  - e. \$6300K taxes on interest

- 8. Land Clean up- Dick McCulley
  - a. Perimeter Clean up guest speaker: Jenifer Hansel: USFS representative
    - i. 80 acres to be cleaned up
    - ii. Work was contracted out
      - 1. Engines 14 & 15 and firefighters out of Chester
    - iii. Will address PG&E easement cleanup with PG&E
    - iv. Questions
      - 1. How will piles be removed
        - a. Will be burned in the winter
      - 2. When will area east of Ash Way be cleaned up?
        - a. It is not in scope for USFS cleanup since it is part of the common land
  - b. Lot Clean Up and Maintenance guest speaker: Dave Harp
    - i. New ordinance requires 100 foot defensible space around all lots
      - 1. Limb up trees
      - 2. Mow grass to less than 3 inches
      - 3. Remove pine needles so that coverage is less than 3 inches deep
      - 4. Thin out trees
    - ii. Non-compliance with new ordinance
      - 1. Misdemeanor- 6 months in jail
    - iii. Inspectors have been sent out beginning in April
    - iv. ISO
      - 1. Point rating that takes into account
        - a. Water system (hydrants)
        - b. Fire personnel
          - i. Year round or seasonal
        - c. Fire station equipment
      - 2. Most insurance companies use point rating to determine rates
        - a. AAA does not use the ISO to evaluate rates
      - 3. Mill Creek cannot get a rating lower than a "9"
      - v. Questions
        - 1. Do we need to remove pine needles?
          - a. Pine needles don't negatively impact a "running" fire
          - b. Don't burn your pine needles, chip or remove them
        - 2. Can we stack firewood?
          - a. Don't stack against decks or cabins
          - b. Clean area around stacks
        - 3. Who do we call to report an unattended fire?
          - a. The Forest Service will investigate reports and Cal Fire may follow up
        - 4. Are recreational (campfires) still allowed?

- a. Yes. If it looks like a debris burn, then no
- b. No permit is required
- 5. Will you submit to put in another tank?
  - a. No, that is done by your association
- 6. What height should you ladder a tree to?a. Ladder to 10 feet or 1/3 the tree's height
- 7. What number should we call for complaints?
  - a. 530-528-5199
- 8. Are fireworks legal?
  - a. No, they are illegal on cabin sites
