- 4. Cal Trans Tree Removal along HWY 172 Sandi, Mark B Sandi talked to Tim Langher of CalTrans last week. Indicated that we are on the list for hazard tree removal from Cal Trans right of way. HOA marked trees with X's to be removed but these trees not confirmed for removal and no date set at this time. Tehama County RCD (Chris Wagner) wants to remove hazardous trees will focus on Common Land and potentially on private lots. Mark Black is in contact with Wagner.
- 5. R&S Tree Removal Mark B **Priority is trees on upper Tamarack, including the large downed tree.** We still have \$4,000 un expended from last year's contract with R&S and will not be released until contracted work is completed.
