Elections for MCSHA Board of Directors have been finalized. This was an uncontested election – two nominees for two open positions on the Board – so Preston Dickinson and Betsy Karle are elected "by acclamation." They will begin serving 3-year terms on the MCSHA Board after the Annual Meeting. Many thanks to outgoing board member, Mark O'Sullivan, who served as Treasurer, for his years of service to the community. - 3. Names and addresses of cabin owners can be obtained from a Board member. We do not place this information on the website for privacy concerns.
- 4. A proposed budget for Fiscal Year 25-26 is included in this email.
- 5. The annual cleaning of lots should be completed by <u>June 30.</u> Please be extremely careful if you are burning debris on your lot and strictly follow CAL FIRE guidelines. <u>Never burn on a red flag day</u>. Call the Tehama County Air Pollution Control District at 530-527-3717, option 4 to determine if burning is permitted.
- 6. Garbage bins are again located on the creek-side of HWY 172 across from Dogwood Way for your convenience. **Only household garbage is acceptable-** no construction

debris is allowed and we are charged extra if any is present. If the dumpsters are full, please take your trash home with you- do not leave it beside the dumpsters. Notify a board member and we will arrange for an additional pickup. Please make sure the locks are locked when you leave. *COMBINATION* is 2427.

Extensive amounts of work continue in the forest surrounding our community in the wake of the Park Fire. We have been informed that Hwy 172 from Mineral near Mt. Lassen Avenue to approximately 5.5 miles east of this junction, near Hole in the Ground Road will be closed by CalTrans for several months. Mill Creek will still be accessible from the east side of Hwy 36. We will communicate actual closure dates when we receive them. Please use caution with the large amount of heavy equipment that will be operating in and around our community. Our public agencies are working hard to help restore the forest and keep visitors safe.
